- (b) Upon the dissolution of the corporation and after satisfying the interests of its creditors in all its debts, obligations and liabilities, its remaining property shall be distributed or disposed of to one or more organizations in Canada that have similar purposes to those of the Corporation at the time of dissolution as determined by the board of directors by resolution.
- (c) The corporation is authorized to establish three (3) classes of members as follows:
- 1. Regular Members Members in this class are entitled to receive notice of and attend all meetings of members and each such member is entitled to one (1) vote at such meetings, except meetings at which only members of another class are entitled to vote separately as a class.
- 2. Affiliate Members Members in this class are not entitled to receive notice of, attend or vote at meetings of the members.
- 3. Association Members Members in this class are not entitled to receive notice of, attend or vote at meetings of the members.
- (d) Any by-law, amendment or repeal of a by-law shall require confirmation by Special Resolution of the Members.
