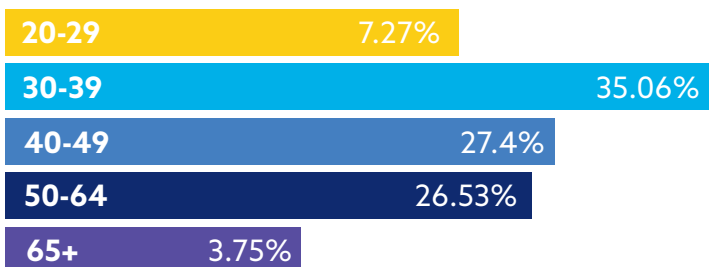

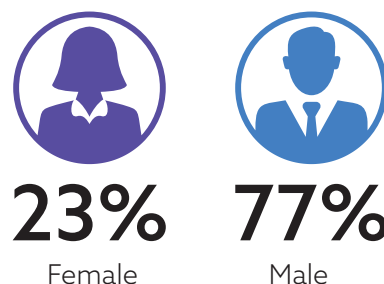

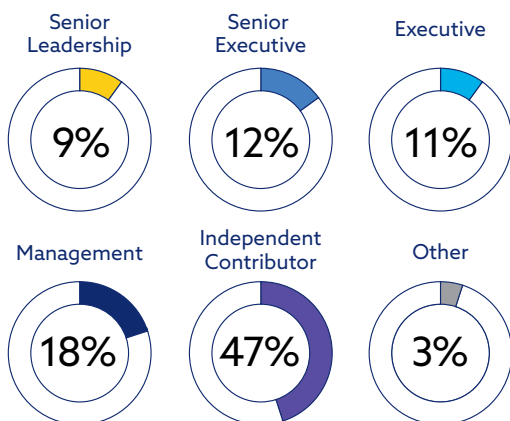
Age Distribution:



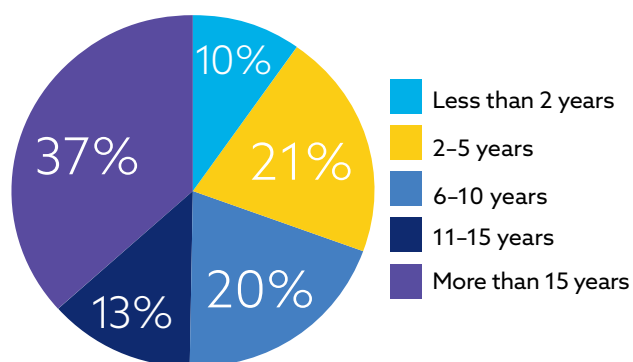

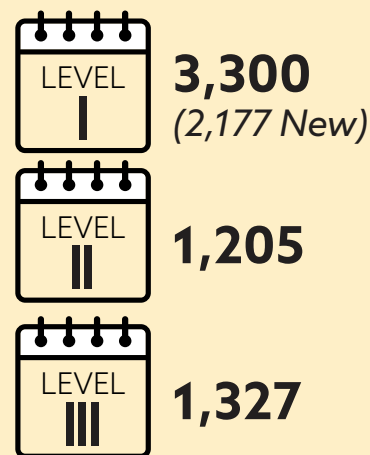

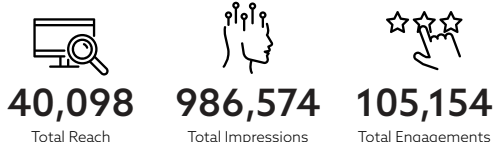
